

## PERSONAL DATA CONSENT FORM

This Personal Data Consent Form (the “**Consent Form**”) constitutes the entire part of the Service Agreement (the “**Agreement**”) concluded between you (the “**Customer**”) and **Eximagro LP**, the legal entity established under the laws of the United Kingdom of Great Britain and Northern Ireland, company number: SL032547, with its registered address at: Suite 110 12 South Bridge, Edinburgh, Scotland, EH1 1DD (the “**Provider**”), and aims to familiarize you with the types of personal data (the “**Personal Data**”) you have to provide in order to receive the requested number of Products.

All terms that are not defined in this Consent Form, but mentioned in capital, have the same meaning as in the main Agreement.

1. By concluding the Agreement, you agree to provide the Personal Data that may be requested while executing of the Agreement by the Provider, its affiliates, agents or partners. You agree to provide following Personal Data:
  - full name;
  - email address;
  - phone number;
  - country of residence;
  - other information about you that you provide by filling any forms on the Provider’s website or necessary by default to provide you the Services under Agreement.
2. The collection of the specified categories of the Personal Data constitutes the Provider’s legitimate interest required for the performance under the Agreement between you and the Provider.

In certain cases, when additional verification by a bank or government authority is required to comply with applicable legislation, including but not limited to the governmental rules, anti-money laundering (“**AML**”) or “know-your-customer” (“**KYC**”) policies, the Provider may require you to provide additional information.

**BE AWARE THAT PROVISION OF ANY ADDITIONAL INFORMATION, AS MAY BE REQUIRED BY THE APPLICABLE LEGISLATION AND/OR FINDINGS OF THE GOVERNMENT INSPECTIONS, IS A COMPULSORY CONDITION FOR THE SUBSEQUENT TOKENS HOLDING.**

3. The Provider will collect your Personal Data and may transfer it to any company of the Romad Group for the following purposes:
  - to identify you;
  - to process transactions and send notices about your transactions;
  - to transfer the Products;

- to protect in full your legal interests;
- to perform the Provider’s obligations regarding the Agreement and any other contracts concluded between you and Provider;
- to fulfill mutual obligations under the applicable legislation;
- to provide you with the full scope of information regarding Product;
- to handle communications with you and respond to you requests;
- to detect, investigate and prevent unauthorized activities and fraudulent transactions.

4. You enjoy all rights provided by the applicable legislation, including following rights provided by EU General Data Protection Regulation:

to access your personal data	by requesting us directly via any mean indicated in Agreement
to restrict the processing of Personal Data if (i) the processing of your Personal Data is unlawful; (ii) the Provider no longer needs your Personal Data to process it.	
to get a copy of your Personal Data and receive your Personal Data in a machine-readable format	
to object the use of your Personal Data	
to correct your personal data	
to withdraw your consent if you are a resident of EU	
to request for your Personal Data erasure	
the right to lodge a complaint with a supervisory authority if you are a resident of EU	the complaint can be filed both before the relevant Data Protection Authority

5. In certain cases the Provider will not able to enforce some of the abovementioned rights according to applicable legislation (e.g., AML) or requirements of public authorities.

6. You may withdraw your consent at any time, considering the fact that such withdrawal shall not affect the lawfulness of the operations carried out prior to you withdrawal.
